		Hertel explains they missed placing June's financials in the packet, so all they have is July's.
		Mishler asks what the \$91,000 for Great Northern Staff Administrators is. Chief explains it's the name of the company that does payroll.
Financials (All Agencies)	Discussion/Action	Brown asks for an itemization of the \$51,000 check she signed for SW Polk. She states they used to get a break down of the 40/40/20 split. Hertel explains the breakdown for the \$51,000 is in the financials. Brown says last year she asked for an itemized bill for the attorney for 2020. Hertel says he doesn't remember hearing that, but he will write it down. Brown says she'd also like to see a breakdown of maintenance to vehicles. Hertel says that is all attached to the check when they sign it. Brown said what she said she didn't see the breakdown, just a receipt for the amount.

		Watson asks about the bond account balance. He asks to have it next week. Mishler asks for clarification. Hertel explains the account was at \$27,000 because previous financial persons inappropriately did bill pays, and now that it has been reviewed by a third party, they need to move approximately \$236,000 into the account.  Motion passes unanimously  Brown asks when West Valley is changing from US Bank to First Federal. Hertel explains they need to allow time for the checks from US Bank to clear.  Motion: Brown Second: Whitman I move to accept our financials Motion passes unanimously  Patty Books — Expresses extreme sadness for the passing of Scot
Audience Participation	Discussion	Breeden. She requests the boards honor his passing by showing respect for their position and the people they represent. She expresses that Chief Hertel has his own agenda and that he is at fault for Willamina's station being "closed for 7 months".  Harry Cooley — Expresses appreciation for everyone coming together over Scot Breeden's death.  Gary Brooks — Asks how many SW Polk board members listened to last night's meeting at West Valley. He asks Rod, after sitting through the meeting, what would make him want to join with this board and he joins them he's no better. Brooks says \$27,000 was given to Chief Hoxie, although the Fire Chief is not allowed to spend over \$5,000 "on any issue" according to board policy. He states last month's expenses were double. He states the Chief is settling a BOLI claim from a Sheridan employee and he doesn't think the board should allow the Chief to handle it.

		Patty Brooks, Rock Creek Road – Asks that the West Valley board submit a request that when an approval or denial for chief Hertel's vaccination exemption is approved by OHA they get a copy of it. Express she saw power corruption during West Valley's board meeting last night.
		Gary Brooks, Rock Creek Road – apologizes for "mouthing off" at the meeting last night. Warns against approving the 190 agreement due to lack of administrative staff. Tasks Greenhill with setting a committee with determining accuracy of financials.
		Milan Miller, Rock Creek Road – Asks for an explanation for how they built stations in SW Polk without permission from Salem or Dallas. Davis says there is no requirement for the SW Polk Fire District to seek approval from any other agency. Miller asks about a rumor that SW Polk may have to borrow money. Watson says they have not exceeded their budget and they have money left over. Brown clarifies that a fire district is separate from an ambulance service area, and that West Valley's operating budget may run short before taxes come in so they may have to borrow money because there isn't enough cash carry over from last year.
		Mishler asks SW Polk if there's anything they'd like to see on the IGA. Watson says they have a list. Greenhill says West Valley has a special meeting set up for Monday to discuss what they would like. Brown asks if Greenhill and Alger will meet with two people from SW Polk after the West Valley meeting. Greenhill answers yes. Brown asks if they will still be open to Sheridan. Chris answers yes. She explains if they do not make a decision soon, current employees will burnout like herself. She states it has become a toxic environment.  Michaela Woods, Union president, reads a statement supporting the
Union	Discussion	three-district consolidation. She states that zero days, so far this month, did not require Overtime and requests immediate hiring. Brown asks about the prior statement from the Union allowing part-time employees. Woods states they have a list of part-timers, but expresses they are not enough. Mishler asks what else they want to see aside from more people. Woods suggests they hire people to work alongside those with experience in the district and that the board needs to set the tone and direction moving forward. Mishler talks about wanting a 12-hour car in West Valley. Woods states the Union doesn't support it because they prefer a 24-hour shift schedule.

Greenhill asks Hertel if "this Agreement calls for the sharing of personnel resources and personnel services, but does not provide for the creation of joint employees among the Parties" is strictly related to the administration. Hertel says no, it is related to all employees. Greenhill suggests adding at the end of the sentence "amongst the administrative staff".

Discussion of paying overtime for shared staff. Hertel says the reason it's written this way is to make it less complicated. He goes on to say that Kimball explained it's harder to track the overtime the way they are currently paying it, and the alternative would be the agency being covered by the employee would reimburse the host agency, which would be Hertel's recommendation. Brown agrees it would be a better choice.

Greenhill adds **Section 3.1** to read "line staffed employees who are shared and work at another agency location, under this agreement, will be paid by their employed agency. These costs will then be reimbursed by the agency receiving service."

### Section 4.1.2

Mishler states he understands the plan will be to move the offices to Salt Creek and asks who will be at the Willamina station. Hertel explains that he hopes to keep Christine Talley in the Willamina office, but she will be half time. Brown expresses concern that Todd Kimball was brought in to help the Finance Assistant transition to doing payroll and that he is still being used. Mishler asks if the contract with Todd Kimball is being split 50/50. Hertel explains the hours Todd works are kept track of for each department and are only charged 50/50 if he does work for both districts. Discussion of outside consultants.

Mishler expresses frustration that board packets are not provided in a timely fashion to board meetings. Hertel explains that he can't hire enough people to provide that under this IGA.

### Section 5

Greenhill asks Chief Hertel what his operations team. Hertel points to the staff report which includes an 80/20 split of the operations team and explains it will include supervisors of lieutenants and possibly a single BC.

### Section 6

Hertel says this section was written before SW Polk was granted permission to run an ambulance and will need to be rewritten. Greenhill states there isn't anything about West Valley's ambulance included either. Brown asks if there are any more resignations. Hertel says the received three more EMT resignations.

### Dear Chief Hertel:

As you know, this firm currently represents West Valley Fire District (West Valley), and SW Polk Co. Rural Fire Protection District (SW Polk) as general counsel. I understand that the Districts would like to create explore various agreements for the sharing of services and personnel between both Districts, and to work towards a possible consolidation of the two Districts

The proposal from the two Districts is for this firm to jointly represent both Districts to guide them collectively through the legal aspects of the consolidation process. The firm will bill SW Polk for the work and SW Polk will in turn seek reimbursement from West Valley so as to share equally in the costs of the joint legal services. We are pleased to assist you, subject to the following understandings.

Although the interests of both Districts are generally consistent and are not presently adverse to each other, each understands that differences may develop during the course of the representation. Even considering the possibility of these differences, both Districts have determined that it is in their individual and mutual best interest to have a single law firm represent both Districts jointly in connection with the proposed consolidation project. Please understand, though, that if our firm determines that a conflict develops, we will advise each District to obtain new legal counsel.

Accordingly, this letter confirms that we will represent both Districts jointly in connection with the proposed consolidation project. This will also confirm that both Districts have agreed to waive any conflicts of interest arising out of our representation of each in the matter described here. It is further understood and agreed that this law firm may freely convey information provided to us by one District to the other District in connection with

this consolidation project and that there will be no secrets or confidentialities between the Districts regarding the consolidation.

According to Oregon State Bar rules, the firm may not engage in the representation of one client that conflicts with another client without informed consent after an explanation about the material risks of and reasonable alternatives to consenting. This means that I must explain to you the pros and cons of consenting, and that the firm cannot proceed with representation of the Districts regarding consolidation unless I receive consent from both Districts.

In deciding whether or not to consent, you should consider how our representation of the Districts, as described above, impacts you. For example, clients who are asked to waive or consent to conflicts typically should consider whether there is any material risk that "their" lawyer will be less zealous or eager on their behalf due to the conflict. Similarly, clients should consider whether there is any material risk that their confidences or secrets will be used against them due to the conflict. In the present case, I do not believe that there is a material risk of either type because it appears that all clients are merely exploring their options regarding consolidation and desire the same outcome. Nevertheless, these are issues that you should consider for yourself on behalf of each District.

Please review this matter carefully. If you have any questions that you would like me to answer before reaching a decision on this issue, please let me know.

The Oregon State Bar Rules also require that I recommend you consult with independent legal counsel before you reach a decision on whether to consent to this arrangement. You are not obligated to consult legal counsel if you do not wish to do so; however, the choice is yours.

If, after such review as you believe appropriate, you decide to consent to the firm's representation as described here, please sign and date the letter and send a copy back to me. For expediency on this matter, you could choose to scan and email me the signed letter.

## INTERGOVERNMENTAL AGREEMENT FOR SERVICES - Operations Staffing Shift Coverage Mutual Aid -

This Agreement, by and between Sheridan Rural Fire Protection District ("Sheridan"), Southwestern Polk County Rural Fire Protection District ("SW Polk"), and West Valley Fire District ("West Valley"), is entered into for the purpose of exchanging fire operations staffing services between the Parties.

### **RECITALS**

WHEREAS Oregon Revised Statutes (ORS) Chapter 190 authorizes units of local government to enter into written agreements with other units of local government for any or all of the functions and activities of a party to the agreement; and

WHEREAS, each Party is a duly organized rural fire protection districts established under ORS Chapter 478 and the Parties have a long history of working collaboratively; and

WHEREAS, the purpose of this Agreement is to improve operational efficiency and service levels of all Parties; and

WHEREAS, the Parties wish to build upon the existing mutual aid relationship between the Parties such that each Party may request firefighter personnel shift coverage from the other Parties,

NOW, THEREFORE, in consideration of each Party's performance of the covenants, terms and conditions herein and the benefits the Parties receive, the Parties mutually agree as follows:

### **AGREEMENT**

### **SECTION 1 – PURPOSE**

- 1.1 Each Party has occasion to need additional personnel to fill gaps in shift coverage; this Agreement is intended to set out the process whereby one Party can request personnel to provide shift coverage and the other Parties can provide the personnel. Providing shift coverage to a requesting Party will always be discretionary with the supplying Party; this Agreement does not establish a requirement for providing personnel to other Parties for shift coverage. The purpose of this Agreement is to establish procedures for the Parties to share operational fire and life safety personnel over the combined territories of the Parties. It is hoped that sharing these operational staff services, will result in costs savings and economies of scale that will benefit all Parties and the residents within each Party's territory.
- 1.2 Recognizing the purpose and the spirit with which this Agreement is entered into, each Party agrees to cooperate, consult, meet and work together in resolving, to the satisfaction of each Party, any question or problems which may hereafter arise in connection with the performance of this Agreement prior to seeking any administrative, mediated, or judicial resolutions.

### **SECTION 2 – TERM; TERMINATION**

- 2.1 This Agreement shall begin on September \_\_\_, 2021, provided it is first signed and approved by each respective Board of Directors ("Effective Date"). This Agreement shall continue in effect until terminated as provided below.
- 2.2 Any Party may unilaterally terminate its participation in this Agreement. To unilaterally terminate participation in this Agreement, the terminating party must provide at least 60 days prior written notice to the other Parties, stating the date of the termination. If notice is provided under this provision, the Parties will continue to operate under the Agreement until the effective date of the termination. If only one Party terminates its participation, the Agreement will remain in effect as to the remaining Parties, until such time as the other Parties terminate their participation.
- 2.3 If a Party fails to pay the compensation as detailed in Section 5 below, another Party may terminate this Agreement subject to the good faith communication and reconciliation requirements in Section 1.2, and subject to the terminating Party providing the other Parties written notice of the breach and thereafter such notice providing the breaching Party at least 14 calendar days to cure the breach. Any termination under this subsection is without prejudice to any obligation or liability of the Parties already accrued prior to such termination.

### **SECTION 3 - EMPLOYMENT STATUS**

This Agreement calls for the sharing of personnel services, but does not provide for the creation of joint employees among the Parties. Each employee providing services under this Agreement is and will remain solely an employee of original employer. Each employer shall be solely responsible for payment of all wages, insurance, PERS, benefits, employment taxes, workers' compensation insurance, and any other applicable employment-based benefits for its own employees. The Parties agree and understand that at no time will any employee who provides services under this Agreement be considered an employee of another Party, or a joint employee, for any purpose. The employees providing services under this Agreement shall be governed by and shall apply the rules, policies, employment contracts (if applicable), performance standards, and regulations of the employing Party. At no time will employees providing services to another Party be subject to any disciplinary policies or procedures of the other Party. Employees will remain under the control and supervision of employing Party while providing the Services under this Agreement.

### SECTION 4 - SERVICES TO BE PROVIDED ("Services")

- 4.1 Firefighter staffing. A Party in need of Firefighter staffing may make a request to the other Parties to fill staffing needs of the requesting party. The requesting Party will make the request with as much lead time as reasonably possible under the circumstances. In general, a request for staffing will be for the staffing of a full shift. Requests and responses for staffing shall be made between the administrative team of each Party.
- 4.2 Good faith. Each of the Parties agrees to attempt to furnish to a requesting party such assistance as the requesting party may deem reasonable and necessary. Provided, however, that the Parties to whom a request is made shall have discretion to refuse

- such request if sending such assistance may lead to an unreasonable reduction in the level of protection within its jurisdiction.
- 4.3 Supervision. When personnel are furnished under this Agreement, the Party requesting the staffing personnel will have overall operational supervision of the supplied personnel during the period the personnel are on shift with the requesting Party. Provided, "supervision" as used in this section refers to operational conduct during the specific shift coverage; each staff person providing services under this Agreement remains an employee of the supplying Party and is subject to the personnel policies solely of that employing agency.
- 4.2 Mutual Aid. The Parties are all mutual aid partners, and except as modified in this Agreement, that relationship will continue in terms of responding to individual calls for service and overall fire service operations.
- 4.3 The services to be provided are in the nature of operational services, with each Party reserving to itself all policy functions functions under the authority of each respective Party's Board of Directors. As a result, no Party shall have authority for the provision of Services without the proper budgetary appropriations, delegation of authority, or other policy-level authorization from each Party's respective Board of Directors.

### **SECTION 5 - COSTS**

The requesting Party will reimburse the supplying Party for the costs of each firefighter shift provided under the Services. The reimbursement will be for the actual costs of providing the shift coverage – meaning that shift coverage may come at an overtime rate or a regular rate, depending on the status of the firefighter providing the shift coverage. Reimbursements between the Parties will be made on a monthly basis.

### SECTION 6 - REVIEW, EVALUATION, AND QUALITY ASSURANCE

Each Party must notify the other Parties as soon as possible of incidents that affect the quality of service delivery under this Agreement. The Parties agree to work diligently towards resolving any issues that may arise.

### SECTION 7 - LIABILITY/INDEMNITY

7.1 To the extent allowed by the Oregon Tort Claims Act and the Oregon Constitution, each Party will defend, indemnify and hold harmless the other Parties, and the other Parties' elected officials, officers, agents and employees, from and against any and all losses, claims, actions, costs, judgments, damages or other expenses resulting from injury to any person (including injury resulting in death) or damage to property (including loss or destruction), of whatever nature, arising out of or related to the performance of this Agreement by the indemnifying Party, including, but not limited to, any acts or omissions of the indemnifying Party's officers, employees, agents, volunteers and others, if any, designated by the indemnifying Party to perform services under this Agreement, as long as such acts or omissions occurred within the officers', employees', agents', volunteers', or others' proper scope of authority.

Notwithstanding the above, the indemnifying Party will not be held responsible for any losses, claims, actions, costs, judgments, damages or other expenses solely and

- proximately or directly caused by the negligence or intentional acts of another Party or another Party's officers, employees, agents, or volunteers.
- 7.2 This Section does not confer any right to indemnity on any person or entity other than the Parties. It specifically does not waive any Party's reliance upon the limitations of the Oregon Tort Claims Act, the Oregon Constitution or other statutes relating to governmental immunity.
- 7.3 The obligations of the Parties under this section will survive expiration or termination of this Agreement.
- 7.4 Each Party waives all claims against all other Parties for compensation for any loss, damage, personal injury, or death occurring to personnel as a consequence of the performance of this Agreement.
- 7.5 Workers' Compensation. Each Party agrees to provide workers' compensation insurance coverage to each of its employees and volunteers. Each Party recognizes that employer-supervision of individual employees will be provided by their regular supervisors. The intent of this provision is to prevent the creation of "special employer" relationships under Oregon workers' compensation law.
- 7.6 Retirement System Status. The Parties recognize and agree that under this Agreement public employee retirement benefits and social security benefits accrue in the manner prescribed by the employee's regular employment and are the responsibility of the regular employer as if the employee were performing the employee's regular duties. No additional benefits arise due to participation in Services under this Agreement.

### **SECTION 8 - NOTICE**

Any notice required by this Agreement shall be given by hand delivery or by placing said notice in the United States Mail, first class postage pre-paid, and addressed as follows:

All prior agreements, understandings or the like, whether written or verbal, are superseded by this Agreement and shall be of no force or effect. Any amendment to this Agreement shall be in writing and signed by the representatives of the Parties as duly authorized by the governing body of each Party.

### **SECTION 10 - EXECUTION**

The execution of this Agreement by each of the undersigned is done pursuant to the authorization of the governing body of each Party, voted upon in an open meeting in accordance with Oregon law, and each person executing this Agreement hereby certifies that they are authorized to execute this Agreement. ### INTERGOVERNMENTAL AGREEMENT FOR SERVICES

This Agreement, by and between Southwestern Polk County Rural Fire Protection District ("SW Polk") and West Valley Fire District ("West Valley"), is entered into for the purpose of exchanging administrative services and other related services between the Parties.

### **RECITALS**

WHEREAS Oregon Revised Statutes (ORS) Chapter 190 authorizes units of local government to enter into written agreements with other units of local government for any or all of the functions and activities of a party to the agreement; and

WHEREAS, each Party is a duly organized rural fire protection district established under ORS Chapter 478 and the Parties have a long history of working collaboratively; and

WHEREAS, the purpose of this Agreement is to improve operational efficiency and service levels of the Parties while the Parties explore the options of creating an ORS 190 fire authority agency and eventually explore the options for a full legal consolidation of the two fire districts,

NOW, THEREFORE, in consideration of each Party's performance of the covenants, terms and conditions herein and the benefits the Parties receive, the Parties mutually agree as follows:

### **AGREEMENT**

### **SECTION 1 – PURPOSE**

- 1.1 The purpose of this Agreement is to establish procedures and mechanisms for the Parties to share services over the combined territories of the two Parties. It is hoped that the sharing of services will result in cost savings and economies of scale that will benefit both Parties and the residents within each Party's territory.
- 1.2 In particular, this Agreement calls for SW Polk to provide certain administrative services, including Fire Chief services, to West Valley.
- 1.3 Initially, the services are as set out below, but the Parties anticipate that the services and the mechanisms for sharing the services will be adjusted over time as this relationship matures and as both Parties may agree.
- 1.4 Recognizing the purpose and the spirit with which this Agreement is entered into, each Party agrees to cooperate, consult, meet and work together in resolving, to the satisfaction of both Parties, any question or problems which may hereafter arise in connection with the performance of this Agreement prior to seeking any administrative, mediated, or judicial resolutions.

### **SECTION 2 - TERM; TERMINATION**

2.1 Term. This Agreement shall begin on January 1, 2022 ("Effective Date"). This Agreement shall continue in effect until June 30, 2022, and will automatically renew for

subsequent annual fiscal year periods (July 1 through June 30) until terminated earlier as provided below.

- 2.2 Unilateral termination. Either Party may unilaterally terminate its participation in this Agreement. To unilaterally terminate this Agreement, the terminating party must provide at least 6420 days prior written notice to the other Party, stating the date of the termination. If notice is provided under this provision, the Parties will continue to operate under the Agreement until the effective date of the termination.
- 2.3 Termination for Lack of Payment or for Failure to Provide Services. If a Party fails to pay the compensation as detailed in Section 5 below or if a Party fails to provide the services as detailed in Sections 4 or 7 below, the other Party may terminate this Agreement subject to the good faith communication and reconciliation requirements in Section 1.4, and subject to the terminating Party providing the other Parties written notice of the breach and thereafter such notice providing the breaching Party at least 21 calendar days to cure the breach. Any termination under this paragraph is without prejudice to any obligation or liability of the Parties already accrued prior to such termination.

### **SECTION 3 - EMPLOYEES**

This Agreement calls for the sharing of personnel resources and personnel services, but does not provide for the creation of joint employees among the Parties, among administrative staff. Each employee providing services under this Agreement is and will remain solely an employee of its employing Party. Each Party shall be solely responsible for payment of all wages, insurance, PERS, benefits, employment taxes, workers' compensation insurance, and any other applicable employment-based benefits for its own employees. The Parties agree and understand that at no time will any employee who provides services under this Agreement be considered an employee of another Party, or a joint employee, for any purpose. The employees providing services under this Agreement shall be governed by and shall apply the rules, policies, employment contracts (if applicable), performance standards, and regulations of the original hiring Party. At no time will employees providing services to the other Party be subject to any disciplinary policies or procedures of the other Party.

3.1 Line staff employees that work for the other agency shall be paid by their employer agency and these costs will be reimbursed by the agency receiving service.

### SECTION 4 - SERVICES TO BE PROVIDED ("Services")

- 4.1 SW Polk will provide the following services to West Valley:
  - 4.1.1 Fire Chief services. The SW Polk Fire Chief will also act as the Fire Chief for West Valley and provide all Fire Chief services for both Parties.
  - 4.1.2 Administrative Services. As supervised by the SW Polk Fire Chief, SW Polk will provide administrative services for West Valley, consisting of: finance and budgetary services, clerical services, and administrative assistance for each Board of Directors. These services will generally be provided by administrative professional staff but may also be provided by outside consultants.

- 4.1.3 Supervisory Services. As supervised by the SW Polk Fire Chief, SW Polk will provide supervisory services for West Valley, consisting of: fire and EMS operational supervision, fire marshal, training supervision, volunteer recruitment and supervision, and resident and student program supervision. These services will generally be provided by <u>Lieutenants or operational personnel battalion chiefs</u>, but may also be provided by other appropriate positions as directed and supervised by the SW Polk Fire Chief.
- 4.1.4 Such other services that the parties may mutually agree to in writing via addendum to this Agreement.
- 4.2 This Agreement does not require a certain number of FTE to provide the administrative services and supervisory services. The provision of administrative services and supervisory services is in the discretion of the SW Polk Fire Chief so long as each party receives competent and adequate service.
- 4.3 Operations. Except as expressly provided otherwise in this Agreement, and unless amended by later action of the Parties, the Parties contemplate that responsibility for fire service operations and call responses will continue to be handled by each Party within its own respective territory. The parties agree to allow the Fire Chief complete operational control, including sharing apparatus, personnel and other resources, for the purpose of providing the best possible services globally to all Parties. The Parties are all mutual aid partners, and that relationship will continue in terms of responding to calls for service and overall fire service operations.
- 4.4 The Services to be provided by SW Polk are in the nature of administrative services, with West Valley reserving to itself all policy functions functions under the authority of the West Valley Board of Directors. As a result, SW Polk will have no authority for the provision of Services without the proper budgetary appropriations, delegation of authority, or other policy-level authorization from the West Valley Board of Directors.

### **SECTION 5 - COSTS**

Costs for the Services shared under this Agreement will be split between the parties according to the following percentages for each category of services.

- 5.1 Fire Chief / Administrative Services. SW Polk 50%; West Valley 50%.
- 5.2 Operations / -Supervisory Services. SW Polk 80%; West Valley 20%.

As part of the annual budgeting process, the Fire Chief for SW Polk shall develop a budget for the Services and distribute the proposed budget to each Board of Directors. This budgeting process shall become the basis for the costs that will be split between the Parties in accordance with the percentages above. The percentages for Administrative Services shall also apply to any shared equipment purchased for joint use amongst the Parties. West Valley will reimburse SW Polk for the Services on a monthly basis.

### SECTION 6 - SW POLK AMBULANCE STAFFING

SW Polk is in the process of provideing ambulance services. West Valley has an ambulance apparatus that could be used by SW Polk, if SW Polk staffs the ambulance. If SW Polk decides to staff a West Valley ambulance, SW Polk would put the ambulance into service as a mutual aid ambulance to aid surrounding Ambulance Service Area providers operating under the license of another ASA license holder. SW Polk will be responsible for all staffing costs associated with providing this service. West Valley will be responsible for the ambulance maintenance costs, including the upkeep of all ambulance systems and equipment. SW Polk will be responsible for replacement of any consumable ambulance equipment and inventory items. The gross revenue generated by SW Polk's use of the ambulance will be shared: SW Polk - 50%; West Valley - 50%.

### **SECTION 8 - REVIEW, EVALUATION, AND QUALITY ASSURANCE**

Each Party must notify the other Party as soon as possible of incidents that affect the quality-ofservice delivery under this Agreement. The Parties agree to work diligently towards resolving any issues that may arise.

### **SECTION 9 - LIABILITY/INDEMNITY**

- 9.1 To the extent allowed by the Oregon Tort Claims Act and the Oregon Constitution, each Party will defend, indemnify and hold harmless the other Party, and the other Party's elected officials, officers, agents and employees, from and against any and all losses, claims, actions, costs, judgments, damages or other expenses resulting from injury to any person (including injury resulting in death) or damage to property (including loss or destruction), of whatever nature, arising out of or related to the performance of this Agreement by the indemnifying Party, including, but not limited to, any acts or omissions of the indemnifying Party's officers, employees, agents, volunteers and others, if any, designated by the indemnifying Party to perform services under this Agreement, as long as such acts or omissions occurred within the officers', employees', agents', volunteers', or others' proper scope of authority.
  - Notwithstanding the above, the indemnifying Party will not be held responsible for any losses, claims, actions, costs, judgments, damages or other expenses solely and proximately or directly caused by the negligence or intentional acts of another Party or another Party's officers, employees, agents, or volunteers.
- 9.2 This Section does not confer any right to indemnity on any person or entity other than the Parties. It specifically does not waive any Party's reliance upon the limitations of the Oregon Tort Claims Act, the Oregon Constitution or other statutes relating to governmental immunity.
- 9.3 The obligations of the Parties under this section will survive expiration or termination of this Agreement.

### **SECTION 10 - NOTICE**

Any notice required by this Agreement shall be given by hand delivery or by placing said notice in the United States Mail, first class postage pre-paid, and addressed as follows:

Notice shall be deemed to be received when hand delivered or, if mailed, three (3) days after said mailing. If the mailing address of a Party changes, notice of the change of address shall be given to the other Parties in writing.

### **SECTION 11 - ENTIRE AGREEMENT; AMENDMENT**

This written Agreement represent the entire agreement of the Parties regarding the subject matter of this Agreement and contains all of the terms and conditions of the Agreement between the Parties. All prior agreements, understandings or the like, whether written or verbal, are superseded by this Agreement and shall be of no force or effect. Any amendment to this Agreement shall be in writing and signed by the representatives of the Parties as duly authorized by the governing body of each Party.

### **SECTION 12 - EXECUTION**

The execution of this Agreement by each of the undersigned is done pursuant to the authorization of the governing body of each Party, voted upon in an open meeting in accordance with Oregon law, and each person executing this Agreement hereby certifies that they are authorized to execute this Agreement. 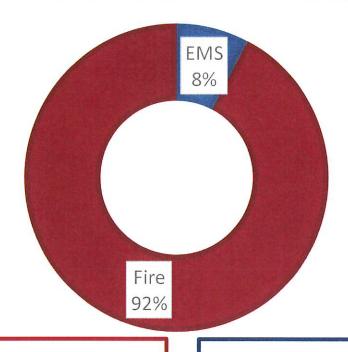

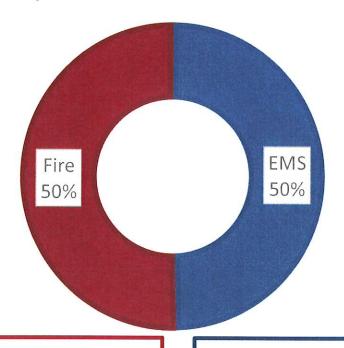
